At 0:52 of the third period the goaltender from the visiting team, Kanta, dropped to the ice, covered a rebound from a shot and the whistle was blown to end the play. After the whistle had blown number 17 from Nepean (Stephen Mundy) speared the goaltender and immediately number 11 (Andrew Barrett) and number 15 (Josh Hoskins) from Kanata confronted the Nepean player and pushed him behind the net. Once behind the net the three players were pushing, shoving and exchanging blows. Number 17 from Nepean struck one of the players behind the net with a high stick and also a moderate blow to the head, for which he was assessed a minor penalty for high sticking, a minor penalty for checking to the head and the automatic misconduct in addition to his double minor for spearing. Numbers 11 and 15 from Kanata each received minor penalties for roughing for their part in the gathering.

Shortly after the whistle went to kill the play the remaining players on the ice gathered just outside the Kanata blue line along the boards opposite the players benches. The gathering consisted mostly of light to moderate pushing and shoving. However, number 17 from Nepean (Greg Covey) and number 17 from Kanata (Nicholas Coyne) were at the centre of the gathering and did exchange moderate blows to each others heads. Each player was assessed a minor penalty for checking to the head and an automatic misconduct penalty. Please note that the misconduct penalty for number 17 from the visiting team does not appear on the game sheet due to an error, however he was assessed this penalty.
