With 15:30 remaining in the first period, player #22 of the visiting team, Jesse Lepage, checked an opposing player into the boards from behind. He was assessed a major penalty and a game misconduct at the referee's discretion due to the nature of the body check. The opposing player was in a vulnerable position slightly away from the boards, but was able to protect himself with his arms upon impact, and as such, a Major penalty was warranted as per rule 53.

With 14:49 remaining in the second period, player # 18 of the visiting team, Darren Mooney, hooked an opposing player in Mooney's defending zone as the player was breaking towards the net. A delayed penalty was signalled. As the play made its way to the net, the goaltender froze the puck and play was stopped. A scrum ensued, and a fight broke out between Mooney and player # 16 of the home team, Zach MacMillan. There was no clear agressor or instigator in this fight. Both players were assessed a major penalty for fighting, and a game misconduct.

With 8:24 remaining in the second period, player # 16 of the visiting team, Brandon Trimble, fought player # 18 of the home team, Dan Hitchcock near centre ice. The two players had skated up ice in close proximity to one another, however it was not clear to the referee who instigated the fight. As such, both players were assessed a major penalty for fighting and a game misconduct.

With 4:09 remaining in the second period, player #9 of the home team, Steven Parker was hit forcefully and cleanly into the boards by a Carleton Place defenceman in Parker's attacking zone, causing a turnover and a Carleton Place breakout. Visibly irritated by the body check, Parker began to follow player #27 of the visiting
